The following draft Rules which the Government of Goa proposes to make in exercise of the powers conferred by sub-sections (1) and (2) of section 28 of the Goa Medical Council Act, 1991 (Goa Act No. 6 of 1991), so as to further amend the Goa Medical Council Rules, 1995, are hereby pre-published as required by sub-section (1) of section 28 of the said Act for information of all the persons likely to be affected thereby and notice is hereby given that the said draft Rules will be taken into consideration by the Government after expiry of a period of fifteen days from the date of publication of this Notification in the Official Gazette.

All objection and/or suggestions to the said draft Rules may be forwarded to the Joint Secretary (Health) to the Government of Goa, Public Health Department, Government of Goa, Secretariat, Porvorim, Goa before the expiry of the said period of fifteen days so that they may be taken into consideration at the time of finalisation of the said draft Rules.

DRAFT RULES

In exercise of the powers conferred by sub-sections (1) and (2) of section 28 of the Goa Medical Council Act, 1991 (Goa Act 6 of 1991) and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Medical Council Rules, 1995, as follows, namely:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Medical Council (Second Amendment) Rules, 2020.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. *Substitution of rule 98.*— In the Goa Medical Council Rules, 1995, for rule 98, the following rule shall be substituted, namely:—

“98. *Charging of fees.*— Fees shall be levied by the Council as shown in Table below.
